

Westmere School Enrolment Scheme



Home Zone

- All students who live within the home zone described below (and shown on the attached map) shall be eligible to enrol at the school.

Starting at 21 Meola Road travel north west to meet the shore, follow the eastern shoreline to West End Road (1/71 and 2/68 included) to meet the north eastern corner of Cox's Bay Park.

Continue east along the northern park boundary, along the walkway and join the end of Livingstone Street. Travel south west along Livingston Street, south east along Regina Street then west onto Richmond Road (277/300 and 409/440 included).

Turn south west into Francis Street and south east onto Old Mill Road, then south along the Bullock Track. Retrace back up along Bullock Track and west along Old Mill Road (both sides included) along Savage Street and continue north along the eastern boundary of Sir Keith Park Memorial Airfield back to the starting point.

All residential addresses on both sides of boundary roads and exit roads off boundary roads are included in the zone unless otherwise stated. Proof of residence within the home zone will be required.

Special Programme Enrolment Scheme

Nga Uri o Nga Iwi is Westmere School's special programme with a maximum roll of 80 students.

All students who live within the home zone and who meet the criteria for entry into the special programme will be enrolled ahead of out of zone students

Special Programme Enrolment Criteria

Nga Uri O Nga Iwi operates Level 1 and Level 2 Maori medium programmes.
This is the criteria for entry, as required by Section 11C (1) (c) of the Education Act.

- Students have attended kohanga reo or puna reo for two years or have had exposure to Te Reo Maori within their whanau to ensure they are able to participate in everyday conversations in Maori.

Where a student meets the above criteria, order of entry will be against the following priorities:

- a. First priority must be for in zone students.
- b. Second priority is given to any applicant who is a sibling of a current student within the special programme.
- c. Third priority is given to any applicant who is a sibling of a former student of the special programme.
- d. Fourth priority is given to any applicant who is a child of a former student of the special programme.
- e. Fifth priority is given to all other applicants

Procedure for enrolment in case of more applicants than available places

If there are more applicants in the second, third, fourth or fifth priority groups than there are places available, selection within the priority group must be by ballot conducted in accordance with instructions issued by the Secretary under section 11G(1) of the Education Act 1989.

Parents will be informed of the date of the ballot by notice in a daily or community newspaper circulating in the area served by the school.

Westmere School Out of Zone Enrolment Scheme : (Amendment) May 2011

Each year the Board will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The Board will publish this information by notice in a daily or community newspaper circulating in the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolment will be processed in the following order of priority:

| First Priority | must be given to students who have been accepted for enrolment in the above special programme run by the school (Nga Uri O Nga Iwi) and approved by the Secretary of Education. |
| Second Priority | must be given to applicants who are siblings of current students. |
| Third Priority | must be given to applicants who are siblings of former students. |
| Fourth Priority | must be given to any applicant who is a child of a former student of the school. |
| Fifth Priority | must be given to any applicant who is either a child of an employee of the Board of the school or a child of a member of the Board of the school. |
| Sixth Priority | must be given to all other applicants. |

If there are more applicants in the second, third, fourth or fifth priority groups than there are places available, selection within the priority group will be by a ballot conducted in accordance with instructions issued by the Secretary under Section 11G(1) of the Education Act 1989.

Parents will be informed of the date of any ballot by notice in a daily or community newspaper circulating in the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.
