# Qualifying Parishes for St Joseph's School (Temuka)

## Primary Qualifying Parish - The former Parish of Temuka

"St Joseph's " Temuka

"Commencing at the southern-most point of the Parish boundary on the coastline of the South Pacific Ocean at a point in line with Beach Road, Seadown; bounded thence in a clockwise direction, firstly westerly, to and by the centre lines of Beach Road, Seadown Road, and Dominion Road; thence northerly and westerly generally by the centre lines of Wilson Road, Arowhenua Road and Roaring Camp Road, to and across the Opihi River to follow the centre line of Waiapi Road to Station Road; thence by the centre lines of Station Road, Walker Road, Waitohi Temuka Road, and the Main Waitohi Road to the northern end of McCully Road; thence north-easterly across the country to Rangatira Valley Road to follow the centre lines of Rangatira Valley Road, Seven-Sisters Road, Goodwin Road and Winchester Hanging Rock Road to its junction with the Winchester-Geraldine Road; thence northerly on the Winchester-Geraldine Road to a point in line with Harrison Road and easterly across country to follow the centre lines of Harrison Road, Winchester Orari Highway (SH1), Barker Road, Muff Road and Ohapi Settlement Road, to and across the Orari River to follow the centre line of Burnham Road to the bank of the south-west channel of the Rangitata River; thence south-easterly by the south-western bank of this river channel to the coastline, thence south-westerly by the coast line to the commencing point opposite Beach Road, Seadown."

## Secondary Qualifying Parish - The former Parish of Pleasant Point

"St Mary's" Pleasant Point

"Commencing at the north-eastern corner of the Parish boundary on Rangatira Valley Road at a point in line with with McCully Road; bounded thence in a clockwise direction, firstly southerly across country to follow the centre lines of McCully Road, Main Waitohi Road, Waitohi Temuka Road, Walker Road, Station Road and Waiapi Road to and across the Opihi River to follow the centre lines of Roaring Camp Road, Arowhenua Road, Wilson Road and Levels Plain road to its junction with the Timaru-Pleasant Point Highway (SH8); thence north-westerly and south-westerly generally by the centre lines of the Timaru-Pleasant Point Highway (SH8), Rolling Ridges Road, Sutherlands Road, Taiko Hall Road, Taiko Road and Pareora Ford Road to the Pareora River; thence westerly by the centre line of the Pareora River to the junction of the Motukaika River; thence south-westerly by the centre line of the Motukaika River to its source and thence to the Summit of the Hunter Hills; thence northerly by the Summit of the Hunter Hills to Mt. Nimrod and thence by a right line to Mt. Smith; thence north-easterly to and by the centre line of Coal Creek to its junction with the Tengawai River near the intersection of Cave-Albury Road (SH8) and Monavale Road; thence north-easterly across the country firstly to Mt. Gay and thence to the Opihi River at the junction with the Opuha River; thence easterly generally, firstly by a right line across the country to the intersection of Saddle Road and Coles Road and thence by the centre lines of Saddle Road, Galbraith Road, and Rangatira Valley Road to the commencing point in line with McCully Road."

### Secondary Qualifying Parish - The former Parish of Geraldine

#### "Immaculate Conception"

Geraldine

"Commencing at the eastern-most corner of the Parish boundary at the mouth of the Rangitata River on the coastline of the South Pacific Ocean; bounded thence anticlockwise by the centre line of the main channel of the Rangitata River to its headwaters at the junction of the Clyde River; thence by the centre line of the Clyde River to its source and thence to Mt. Tyndall on the Main Divide of the Southern Alps; thence south-westerly by the Summit of the Main Divide to McClure Peak at the head of the Godley Glacier; thence southerly generally to and by the Summit of the Two Thumb Range to Mt. Musgrove and thence to Fox Peak; thence south-easterly to and by the centre lines of the North Opuha and Opuha Rivers to the junction with the Opihi River; thence easterly, firstly by a right line across the country to the intersection of Saddle Road, Limestone Road and Coles Road and thence by the

centre lines of Saddle Road, Galbraith Road, Rangatira Valley Road, Seven Sisters Road, Goodwin Road and the Winchester Hanging Rock Road to its junction with the Winchester-Geraldine Road; thence north on the Winchester-Geraldine Road to a point in line with Harrison Road and east across country to follow the centre lines of Harrison Road, Winchester-Orari Highway (SH1), Barker Road, Muff Road and Ohapi Settlement Road, to and across the Orari River to follow the centre line of Burnham Road to the bank of the southwest channel of the Rangitata River; thence south-easterly by the south-western bank of this river channel to the coastline and commencing point at the mouth of the Rangitata River."
