# KIA ORA AND WELCOME

Lincoln offers a number of postgraduate study options.

These include postgraduate certificates and diplomas, research masters' degrees, PhDs, or taught masters' degrees – which is what this prospectus is about.

Lincoln's taught masters' programmes are made up of courses studied over 12-18 months, depending on your chosen subject and when you start.

A taught master's degree gives you further specialisation through course-based study which you can apply your knowledge immediately, in the workforce, or to continue on to research.

A taught master's is perfect if you have already completed a Bachelor's degree and would like to gain a valuable professional development qualification in a short amount of time.

You can usually complete your taught master's degree in 12 months of full-time study and there is no research thesis requirement. The programme is similar to an undergraduate one, in that you will attend courses, lectures and seminars and have plenty of contact with tutors and other students.

Assessment is through examinations, course work, dissertations and group projects.

Master of Business (Global Management and Marketing)

Nur Khaririyatun, or Khori, is learning skills at Lincoln that she knows will help her in her job when she returns home.

The Master of Management in Agribusiness student works for the Indonesian Ministry of Agriculture.

She chose Lincoln because of its high world ranking.

"The courses are applied and I am sure they will help me in my job. New Zealand is also very good in farming, so I can learn from that environment too."

Khori says she is really enjoying her study at Lincoln.

"Good friends, good environment, and good support from lecturers. It's a comfortable place, which makes study fun."

She has some recommendations for international students.

"Every student should do EAP (English for Academic Purposes) before starting their courses. You learn research skills that are important for assignments, exams and research.

"Before I came here, I was so nervous because my English is not good. Don't worry about your English, as you can learn here. The most important thing is think positive and work hard.

"Please come here, as it's a great experience. New Zealand is a very beautiful country. You will not be disappointed.

"I will really miss all of my lecturers and Lincoln staff when I graduate."

#### SUGANYA KAMARAJ (INDIA)

Master of Science in Food Innovation

Suganya Kamaraj, from Pondicherry in India, is relishing her Master of Science in Food Innovation programme at Lincoln University and the opportunities it will give her in New Zealand.

"I'm a foodie and a mad researcher," she says. "I chose New Zealand as there are plenty of opportunities to work once I have finished the course, especially in the dairy sector.

"Lincoln is well known for its friendly environment and excellent lab facilities. My professors are very kind and helpful. We can contact them by sending them an email and they are available as soon as possible to clarify."

Suganya says the study environment in New Zealand is very different from what she is used to in India, "because here we do a lot of writing work".

- An original or verified copy of your academic records. Documents not issued in English must be
  officially translated and submitted together with verified copies in the original language
- · An original or verified copy of your English test score.

The Master of Business (Finance) is an advanced postgraduate qualification for students who have completed a bachelor's degree.

A student of the Master of Business (Finance) will study finance in New Zealand and international contexts, with reference to corporate firms, corporate finance, SMEs (Small to Medium Enterprises), sustainability, agribusiness, entrepreneurship, innovation and commercialisation. You will also gain a clear understanding of key finance concepts and learn how to apply these practically to resolve business problems and develop successful strategies.

This is a taught master's programme consisting only of course work. There is no thesis requirement. It can be completed over a 12-month calendar year, if begun in November. We also have a February and July intake that takes 18 months to complete, allowing a break to be taken over the summer.

- Can be completed in one calendar year if starting in November
- Broad coverage of all Commerce disciplines
- Specialist courses in Finance

The Master of Disaster Risk and Resilience is taught jointly by members of Lincoln University's Department of Environmental Management and the University of Canterbury's Department of Geological Sciences.

Both universities have experienced and learned much from this decade's Canterbury earthquake sequence, and have been involved in national-level design of research programmes on Resilience to Nature's Challenges.

At the Third UN World Conference on Disaster Risk Reduction in March 2015, the Sendai Framework for Disaster Risk Reduction was adopted and, consequently, disaster reduction protocols are being developed around the world. As a result, future professionals engaged in disaster reduction will require a broad and well-founded understanding of the fundamental causes of disasters, and of the conditions of both natural systems and human systems that allow disasters to occur. The Master of Disaster Risk and Resilience (MDRR) addresses this need.

# Key features:

- Being based in Canterbury gives students a unique opportunity to understand how the region can become more disaster-resilient in the future by learning from recent seismic events
- Christchurch is one of the Rockefeller Foundation's 100
  Resilient Cities and the Canterbury region remains a focus
  of intense disaster recovery and urban renewal
- Joint delivery by Lincoln University (LU) and University of Canterbury (UC).

- Experience in applying learning to specific disaster-reduction-related situations
- Practice in formulating risk communication, risk reduction and resilience strategies and communicating concepts to a wide audience
- An understanding of methodologies to build resilience.

# Career opportunities:

Graduates of this degree could find themselves working in regional or national level roles within Civil Defence and Emergency Management positions in New Zealand or internationally, for example, the State Emergency Management Committee (SEMC), Western Australia's peak emergency management body.

Graduates could also find themselves working in local government or private sector consultancies advising how to reduce the vulnerability of people and communities to disaster, or with international agencies like the United Nations International Strategy for Disaster Reduction, or progressing to PhDs and research roles in organisations like GNS Science.

Lincoln University's Master of Environmental Policy and Management has been designed to equip graduates with the research and analytical skills needed to understand and evaluate the interconnections between the complex issues often described simply as 'environmental'.





#### Refund of student fees


To be eligible for a refund of tuition fees, you must withdraw no later than 21 days after the first day of a full semester, or five days after the start of English Language Programmes or Summer School.

A refund fee of NZ\$1000, including GST, will be charged to all international students who request a tuition fee refund as a result of a semester cancellation or withdrawal, or transferal to another educational institution. This refund fee will also be charged to students who request a refund but have not enrolled or registered.
