New Joint Ministry at St Matthew's, Dunedin

I am delighted to announce the appointment of Reverend Barbara and Reverend Francis Noordanus as Co-Vicars of St Matthew's Parish, Dunedin.

Barbara grew up in Dunedin and was shaped in her early faith by St Martin's North East Valley and then St Paul's Cathedral (where her mother Margaret Tripp continues to worship). Both Barbara and Francis have spent the last 18

years ministry in Eindhoven (Netherlands), part of the Church of England Diocese in Europe, where they had a particular commitment to nurturing young people and families.

Barbara and Francis will be installed as Co-Vicars at St Mathew's parish Dunedin on 24 April 2021. This is the cumulation of a long process for St Matthew's, but with a real sense of God's calling for them and the Parish to start this new journey together. The timing of their appointment comes as Rev'd Dr Peter Ross heads north to Nelson after Easter following his much appreciated interim ministry.

The story of how Barbara and Francis came back to NZ as the Pandemic was taking hold and had a strong sense of God calling them South is worth hearing - and I hope that many will be able to meet them in the future and share in their stories as they start to connect with ours.

Welcome, Francis and Barbara, to the Diocese of Dunedin Whanau and to St Matthew's Parish - we look forward to sharing this new journey together.

Anglican Missions 2021 Lenten Appeal

Please prayerfully consider Anglican Missions 2021 Lenten Appeal.

As Lent draws to a close we want to remind you of the Anglican Missions Lenten Appeal.

This year we are supporting:

 \cdot St Luke's Hospital, Nablus (Diocese of Jerusalem). We hope there will be sufficient funds for the hospital to buy 3 new maternity beds. St Luke's provides critical maternity care for local women in a city of around 300,000 people where Covid-

19 has hampered travel in a region where life for many can be difficult.

- · The Diocese of Egypt Youth Ministry (Province of Alexandria) will be assisted as it rolls out a ninemonth youth leadership programme that aims to build resilience for the next generation of church leaders.
- · The Anglican Church of Melanesia has requested help to install adequate water systems for three of its religious communities in the Solomon Islands. This will not only benefit the religious communities but also nearby villages. Additional funds raised will go to the Christian Care Centre in Honiara which provides support and shelter for vulnerable women and children.

Meeting 9 March 2021

The Diocesan Council and Trusts Board meet monthly as the Standing Committee of the Diocese of Dunedin.



nglican Family Care - Kyle Forde was reappointed to the Board for 2 year term.

- **Home of St Barnabas** Carole Lee Adair was reappointed to the Board for a 3 year term.
- **Dunedin Diocesan Trust Board** this month was the last meeting for Rev'd Fr Hugh Bowron. Bonnie Miller Perry has resigned as she has shifted to Christchurch. Applications for this Board are currently open again. The Trusts Board encourage people to prayerfully consider this and would like to see a greater diversity of competent people on the Board

to help steer this for the future.

Diocesan Council

- **Diocesan Council Visioning Day December 2020** Dio Council reviewed what they had decided to focus on for this year, and have already moved to be more intentional about prayer during meetings and to have a regular slot in the agenda to focus on/review each statute.
- **Selwyn College** Council are continuing to consider how to work with Selwyn on a variety of tasks post Synod. Selwyn has been pulling together a Special Character Committee and the decision was made that Mr. Steve Mitchell be a Diocesan Council member on the Selwyn College Special Character Committee with Mrs. Dot Muir as an alternative. The Bishop is following up on others who could take on a role of an external facilitator.
- **Brockville Cooperating Parish** noting that Brockville has had it's final service, the following motion was carried: That the Co-operative Parish of Brockville be removed from the First Schedule of Statute 3.
- The Diocesan Ministry Educators. Michael Godfrey continues to work on a variety of projects and was involved in the Lay ministry Training day. It has been great to have Anne Van Gend start in her new role (we will report more on initial progress in the future), Anne also participated in the Training Day. John Graveston has spent time in Southland (Archdeaconry meeting), assisted with one of the sessions at the Lay Ministry Training Day and continues to support the Young Adults Group as well as working on Vulnerable Children requirements for the Diocese.
- **Diocesan Registrar's Report** Andrew attended a face to face Diocesan Managers conference in Wellington from 15-16 February. Our Accountant Ginny Kitchingman has tendered her resignation and her last day was 17 March. We have purchased two cars for our educators look out for bright green second hand Toyota Prius Hybrids around the region... with signage to follow.
- **Decisions made during the meeting:** The meeting approved a number of grants as recommended by the Social Justice Committee to Leslie Groves, South Centre, The Home of St Barnabas Trust, Anglican Family Care and Parata Anglican Trust. These grants came to a total of just over \$47,500.

Police Vetting requirements - FAQs

Please read on for further information and FAQs about this process....

Best practice and Diocesan policy is that everyone holding a Bishop's Licence (Clergy or Lay) or involved with other active ministry in a Church (eg Children's Church) is required to have a Police vetting check undertaken every three years.

It is recommended that each year Faith Communities ensure those involved in active ministry (eg Children's Church/Youth Group/ Pastoral visiting team) have up to date Police Vetting checks and that any new volunteers undertake a Police vetting check.

Those holding a Bishop's Licence as a Priest or Lay Minister do not need to action this until you are contacted individually by the Bishop's office when your Licence is due for renewal. Police vetting checks usually are timed to be undertaken when a Licence is renewed or issued.

1. Why do I have to have a Police Vetting check done?

Over the last few years there have been some significant legislation changes in New Zealand and an increasing need for all kinds of sectors in New Zealand to comply with this.

The Diocese, in common with all other Dioceses in New Zealand, sees going through this process as not only as best practice but essential for us to ensure that both the people offering the ministry and those we minister to are safeguarded. It is a basic requirement for ministry and involvement in the Church. This process is being echoed by other public and not-for-profit organisations that are involved with the care of others, especially children, young people and those considered vulnerable in any way. It increases our credibility in society, and helps to remind others that the church is in touch with reality.

It is important for the safety for everyone concerned, and for other agencies we work with, that we are really open and transparent and Police vetting is part of this process.

We don't ever expect that any issues will be raised by the Police vetting of people working on behalf of the Diocese but it provides an important safety net. In the event that anyone's status may change, it's really important that you let us know.

2.I have already had a recent Police check done for my employment/another role I have, do I have to complete a Police vetting for the Diocese?

Yes. While you may have a Police vetting check as part of an existing job or role, the check is only valid for when it is completed and for the requirements of that role. A Police vetting through the Diocese will be at a level which meets Diocesan requirements and at the level of risk for the ministry role you have with the Diocese.

3. What is the difference between Police vetting and Ministry of Justice criminal record check?

Police provide a vetting service for approved agencies that provide care to children, older people and vulnerable members of society in New Zealand.

A Police vetting result may include any information held by New Zealand Police whereas a Ministry of Justice <u>criminal record check</u> will only contain conviction history. For the purposes of the Diocese, it is best practice for the fuller Police vetting to be completed.

4. Why has the process changed significantly since I received my last Licence?

It has been Diocesan policy for some time that Police vetting be undertaken at re-licencing time, the beginning of a new Licence or role, but the procedure for completing Police vetting applications has recently changed.

The Vulnerable Children Act 2014 and it's Regulations have changed the requirements to apply for a Police Vetting check. All checks for those involved in ministry in the Diocese are submitted through the Diocesan office as an "Approved Agency".

**If you are applying for a Police Vetting Check for the first time:

An application form must be completed and returned to

along with copies of two forms of ID - primary and secondary.

These copies need to be noted as true and correct copies either at the Diocesan Office or by an Identity Referee.

The applications are lodged with the Police vetting agency through the Bishop's office.

**If you are applying for a subsequent periodic Police Vetting check (within 3 years after the last one)

If you have had a Police Vetting undertaken through the Diocese within the last three years, you do not need to attach two forms of ID. Instead, please complete the attached confirmation as to whether or not your name has changed since the last Police Vetting. If your name has changed, please attach a supporting name change document.

The applications are lodged with the Police vetting agency through the Bishop's office.

6. Is there an application fee?

As a registered charity, the Diocese is exempt for charges with New Zealand Police vetting.

7. How current do my ID types have to be?

Current identity documents are preferred, but documents that have expired within the past five years may be accepted (eg passport). **Please contact Nicola Wong for specific information.**

8. What is a primary ID?

Primary IDs are:

- Passport (NZ or Overseas)
- NZ Firearms Licence
- NZ Full Birth Certificate (issued on or after 1998)
- NZ Citizenship Certificate
- NZ Refugee Travel Document
- NZ Emergency Travel Document
- NZ Certificate of Identity

8. What is a secondary ID?

Secondary IDs include:

- NZ Driver Licence
- 18+ card
- NZ Full Birth Certificate (issued before 1998)
- Community Services card
- SuperGold Card
- NZ Employee Photo Identification Card
- NZ Student Photo Identification Card
- Inland Revenue number
- NZ issued utility bill (issued not more than six months earlier)
- NZ Teachers Registration certificate

- NZ Electoral Roll Record
- International Driving Permit
- Steps to Freedom Form

9. I don't have any form of Primary ID.

We don't think that the cost of a new birth certificate should be prohibitive to being licensed or undertaking ministry and would encourage people for whom this might be a concern, to discuss this with their faith community. A standard birth certificate is required by the Police. (See the **Dept of Internal Affairs webpage** for more information. Current cost is \$33.)

10.What is needed if one of my ID types doesn't have a photograph (eg. I have a birth certificate and IRD number)?

There are some solutions to this - please don't let it put you off the process. **Please contact Nicola Wong in the Diocesan office for more information and help.**

11. Who is an Identity Referee? Who can witness my documents as true copies?

You can do this in person at the Diocesan office.

If you can't come into the Diocesan office, then Evidence of Identity checks may be completed by an Identity Referee.

An Identity Referee must be:

- · be either a person of standing in the community (e.g. registered professional, religious or community leader, Police employee) or registered with the Approved Agency (a Clergy person)
- · be over 16 years of age.
- \cdot not be related or a partner/spouse.
- · not be a co-resident of the applicant.

12. How does an Identity Referee certify my documents?

To verify an applicant's identity, the Identity Referee must:

- 1. Sight the original versions of each identity document.
- 2. Compare the photographic image with the applicant to confirm they are the same person.
- 3. Sign and date a copy of each document to verify that the documents produced by the applicant relate to that person.
- 4. Provide his or her name and contact details.

Example: I confirm that this is a true copy of the original document which I have sighted. Signed Agnes Blog, 123 Cherry Lane, South Town, ph 0123456. Dated XXXXX

5. Send the signed identity documents to the Approved Agency.

PART TIME PRIEST IN CHARGE/VICAR

Otago Peninsula Parish

The Otago Peninsula Anglican Parish is seeking a permanent part-time Priest in Charge/Vicar.

The post is open to any Priest in Anglican Orders who is entitled to live and work in New Zealand.

The parish is able to support a 50% stipend, and the appointee would be ably supported by a strong team of lay-leaders, two local priests and a number of retired clergy. The appointee would be a

person who values and enhances this leadership, and the appointment would be for a three-year term in the first instance. Accommodation and/or an accommodation allowance on a pro rata basis would be arranged with the successful applicant.

The Otago Peninsula is on the edge of Dunedin City, which provides rich experiences of arts, sports, academic and other cultural benefits. The parish includes suburban and scattered rural communities, and has reflected that diversity over its long history. The story of the parish since its conception has been one of creative and adventurous approaches to ministry and mission. The parish has a strong record of exploring creative and inclusive models of ministry, empowering lay-leadership, engaging actively in social justice issues, affirming women's priestly and other ministries, all underpinned by often innovative yet always faithful sacramental and liturgical worship. In July 2019 the Parish voted to consolidate its ministry, mission and outreach and its liturgical life at St Michael and All Angels' Church in Andersons Bay. The appointee would lead the cooperative amalgamation of the individual faith communities (and their differing traditions), while continuing the parish's developing connections with the various communities that form the demographic of the Otago Peninsula.

The Bishop of Dunedin is looking to appoint Priests who are practising and modelling lives of prayer, a commitment to the Bible, and witnessing to the risen life of Jesus Christ.

Dunedin Diocesan Trust Board (DDTB) Trustee Vacancies

An update on Board members... plus, could you contribute to the Diocese of Dunedin by being a Trustee of the Dunedin Diocesan Trust Board? With Fr. Hugh Bowron and Bonnie Miller Perry stepping down, we have two vacancies to fill...

This year has seen some changes in the DDTB, with Alan Dunbar (Wakatipu Parish) not seeking re-election after his current term ended, Bonnie Miller Perry resigning from the

Board as she has moved to Christchurch and Fr Hugh Bowron standing down from the DDTB as he prepares to finish up at Caversham Parish this Easter and move back to Christchurch as well.

Alan was a long term member of the Board and has always been an active participant, especially looking at the DDTB's investment portfolio and making sure that the right decisions were being made. He was also part of the Earl Street Charitable Trust, and has stepped down from this as well.

Bonnie was one of our newer members who started in July 2019 and who has helped bring diversity and her own unique business experience to the Board.

Hugh has been on the Board since 2014 and at his last meeting Hugh indicated that of all the Boards he has been on, for him this had been the most satisfying. The Board expressed it's appreciation of Hugh, especially his interest in Investment Markets.

Applications for membership of the DDTB will be considered by the Diocese of Dunedin Trusts Board on 13 April 2021. Please send any applications for this before 6 April 2021. We would like to hear from anyone who is interested in becoming a Trustee. We are especially interested in people who have an interest and (preferably) experience in governance and who can add to the diversity of this Board.

The board has two main roles:

First, it manages two investment funds (the Income Fund and the Growth Fund) as trustee for diocesan institutions, e.g. social services, residential and community based services, educational institutions and so on. These bodies deposit funds with it. The total funds under management in the two Funds is currently over \$32 million dollars.

The second major responsibility of the Board is the legal ownership of all Diocesan properties: it acts a trustee for all Diocesan institutions including local churches and parishes, who are the beneficial owners, i.e. they make use of these resources for their mission and ministry. In this capacity, the Board arranges insurance of properties when delegated by the Diocesan Council. It has also taken a leadership role in the assessment of properties for seismic stability.

The Board meets monthly, as does its subcommittee known as the Investment Committee. The Investment Committee monitors current investments to ensure the best returns possible and that they meet ethical business standards. It frequently conducts business by email outside of its monthly meetings as necessary. Board members are able to meet remotely (teleconference, video conference) for anyone who is not in the immediate Dunedin area.

SCOPE What is Scope?

Scope stands for Strandz Communities of Practice for Everyone. The Oxford University Press defines 'scope' as "the extent of the area or subject matter that something deals with or to which it is relevant" with synonyms including freedom, opportunity, room, range, breadth, spread, horizon. A 'scope' (noun) can also be a target, an instrument for observing, viewing, or examining, or a length of cable extended when a ship is at anchor.

These definitions and synonyms reflect a group that has the freedom to observe and explore, while being supported by a strong anchor in Christ.



Coronavirus Covid-19 Level 1 Update

At Level 1 we need to continue to take care of each other and ourselves. We have updated our Level 1 information to remind each other what we need to do....

Although all Church Services and Pastoral care can take place with no restrictions, we need to keep hygiene measures in place. All of us need to keep track of where we have been and who we have seen using the Government Tracer App or our own records. Let's continue to be mindful of others around us in church settings.

If you need a hand with renewing your Government Tracer App posters, contact Peter Mann House: we can help with smaller or larger sized posters and laminating them for protection.

Click on the following for <u>Frequently Asked Questions and Information for Level 1</u>

We are aligning ourselves with advice-resources from the <u>Government on Level 1</u>, and have also developed our own <u>Policy and Guidelines around Level 1 in our Pandemic Response Framework</u> We are still in a pandemic alert system and need to watch we don't become complacent.

Key points for all of us

- While not requiring physical distancing in church, we are encouraging this to continue, especially being sensitive of other's needs (physical distancing) in pews. <u>All church buildings</u> <u>and premises must display the NZ COVID Tracer poster</u> to help with contract tracing if required.
- Remember, while we have access to communion in both kinds, we are not practicing intinction (dipping the wafer into the wine) feel free to acknowledge the cup if you don't want to drink from it: taking the wafer only (communion in one kind) still counts as receiving in both kinds.
- Make sure you have access to face-masks. At Level 1 now you must wear a mask on all public transport, including long distance bus services, all trains and most ferries. Taxi/uber drivers must wear masks and this is recommended for passengers but not compulsory. Have a look at current advice on the use of these. Please follow Government recommendations for mask use when using public transport. Have a look at the posters attached below on how you can make your own masks and check out the videos below:
- Some at-risk people may not be comfortable being with a larger group of people offer other ways of staying in touch with them i.e. the phone, a video messaging system or something similar. It's OK for anyone to wear a face mask for your own or other's protection. **Be kind.** Make a difference by checking-in on others, especially the elderly and vulnerable
- We are continuing to maintain high standards of public health (around cleaning, providing hospitality and so on).
- Look after anyone that needs help. Drop supplies to those at home sick and ensure you have no physical contact.

The Golden Rules for everyone at Alert Level 1

- 1. If you're sick, stay home. Don't go to work or school. Don't socialise.
- 2. If you have cold or flu symptoms call your doctor or Healthline 0800 358 5453 and make sure you get tested.
- 3. Wash your hands. Wash your hands. Wash your hands... for at least 20 seconds (the length of time it takes to sing yourself Happy Birthday!)
- 4. Sneeze and cough into your elbow
- 5. Regularly disinfect shared surfaces.
- 6. If you are told by health authorities to self-isolate you must do so immediately.
- 7. If you're concerned about your wellbeing, or have underlying health conditions, work with your GP to understand how best to stay healthy.
- 8. Keep track of where you've been and who you've seen to help contact tracing if needed. Use the NZ COVID Tracer app as a handy way of doing this.
- 9. All public venues (Businesses, churches etc.) must display the Ministry of Health QR Code for contact tracing.
- 10. Stay vigilant and alert. There is still a global pandemic going on. People and businesses should be prepared to act fast to step up Alert Levels again if we have to.
- 11. People will have had different experiences over the course of the pandemic. Whatever you're feeling it's okay. Be kind to others. Be kind to yourself. Ask for help if you need to.

Are you potentially an at-risk person?

There is guidance for people at higher risk of COVID-19. It includes advice under the different Alert Levels, who is at higher risk, and how they can protect themselves. **Information for at-risk people**

Anyone who has returned to New Zealand from overseas must abide by NZ government requirements. Currently this is to remain at a Government organised quarantine facility. This involves self-isolating by staying indoors and avoid contact with other people for 14 days from the date of arrival and then follow lock down procedures until advised otherwise.
