# A New Year to Experience God's Favour

Bishop Steve has been reflecting on Advent and Christmas - how we can bring our lives back into a new light?

As the excitement and celebration of Christmas night drifts into pleasant memory, I find myself pondering on the echoes of the angels declaration before the shepherds: that message of Glory to God in the highest heaven, and then

peace offered on earth to those whom God favours....

Christmas imagery for me is very much associated with the night – the shepherds on the hillside, the Magi seeking to understand the stars, the dreams given to Joseph – all features of the darkness, stillness and waiting of night. And it's into this darkness that we get to hear of the birth of Jesus Christ – Emmanuel, God with us, the hope and desire of nations. For me this is imagery of comfort and intimacy: it's when we are living in the dark that "the light and life of all people", as John's Gospel puts it, comes to shine on us.

And then this reminder of God's *favour*. God coming into the world because God favours us. Humanity with all it's faults and failings is, at heart, favoured by God.

Towards the end of 2020 I was increasingly reminded that the gospel is good news, and that the church needs to preach this good news in both word and action. When others look at the church – whether they like what they see or not – they need to know that we are proclaiming GOOD NEWS.

My prayer for the start of 2021 is that we both realise for ourselves, and then share with others, the reality of God favour for us: that we are loved, delighted in, and cherished by God. And as a result of this recognition we be enabled to see ourselves and those round about us in a new light. A light which encourages us to grow in love back to God, and towards others as we too delight in God as God delights in us.

May you be blessed with the knowledge of God's favour this year

### Dunedin Diocesan Trust Board (DDTB) Trustee Vacancies

Could you contribute to the Diocese of Dunedin by being a Trustee of the Dunedin Diocesan Trust Board?

Applications for membership of the DDTB will be considered by the Diocese of Dunedin Trusts Board on 26 January 2021. Please send any applications for this before 19 January 2020.

Under Statute 26 each Trustee of the DDTB is appointed for a term of three years and hold numbered seats . At the end of each financial year "the number of members nearest to one third of The Board shall be deemed to have retired but shall remain in office until their successors are appointed". At it's November 2020 meeting, three members of the DDTB were deemed to have retired: they may choose to reapply for another term, but also may choose to stand down.

# We would like to hear from anyone who is interested in becoming a Trustee. We are especially interested in people who have an interest and (preferably) experience in governance and who can add to the diversity of this Board.

#### The board has two main roles:

**First**, it manages two investment funds (the Income Fund and the Growth Fund) as trustee for diocesan institutions, e.g. social services, residential and community based services, educational institutions and so on. These bodies deposit funds with it. The total funds under management in the two Funds is currently over \$32 million dollars.

**The second major responsibility of the Board** is the legal ownership of all Diocesan properties: it acts a trustee for all Diocesan institutions including local churches and parishes, who are the beneficial owners, i.e. they make use of these resources for their mission and ministry. In this capacity, the Board arranges insurance of properties. It has also taken a leadership role in the assessment of properties for seismic stability.

The Board meets monthly, as does its subcommittee known as the Investment Committee. The Investment Committee monitors current investments to ensure the best returns possible and that they meet ethical business standards. It frequently conducts business by email outside of its monthly meetings as necessary. Board members are able to meet remotely (teleconference, video conference) for anyone who is not in the immediate Dunedin area.

### Applications for Social Service and Disadvantaged Youth Funds Grants are now open

The Social Justice Committee (SJC) has opportunities from time to time for parishes and other Diocesan organisations to apply for grants. A further funding

round is taking place with the closing date of midday Friday 11 Feb 2021.

# Please note that funding is limited and the Social Justice Committee may not be able to recommend assisting all applicants with their total costs.

Grants are made by the Diocesan Council on the recommendation of the Social Justice Committee and are expected to be sought on a quarterly basis, with the ability to consider urgent applications outside that time-frame on a one-off basis.

In November 2020 the following funding applications submitted during the last funding round were approved by Diocesan Council: **Leslie Groves Society** for a Tovertafel projector and games (specialist dementia resources); **Parata Anglican Charitable Trust** for a pressure mattress and cushion; **Home of St Barnabas Trust** for a combi catering oven and: **Taieri Parish** 12 months funding for their Friday Light Coordinator.

#### **Child Care Funds**

No applications are sought this quarter for Child Care funds but instead see next paragraphs.

#### **Social Service Funds**

Applications are now able to be made for grants from the **Social Service funds** under the control of Diocesan Council. **Please note that most of the funding available in this category are for projects that come under the definition of aged care.** 

#### **Disadvantaged Youth Funds**

Applications are now able to be made for grants from the **Disadvantaged Youth funds** under the control of Diocesan Council. The Diocesan Council has recently obtained legal advice that monies held in this account may be used for that purpose, and has resolved that **"youth" means those aged between 10 and 24 years of age, i.e. over 10 and under 24 years old.** The term disadvantaged will be given its usual, wide, meaning.

# The closing date for applications for all grants is midday 11 February 2021.

Application forms (see below) may be submitted on-line using <u>this link</u> or in hard copy, but in either case must be sent to the Social Justice Committee care of the <u>Registrar (Mr Andrew Metcalfe)</u>, so that they can be considered by the Social Justice Committee on 16 February, with the Diocesan Council considering grant recommendations at its 9 March meeting.

### The Creed and Crossed Fingers?

Continuing the series by Michael Godfrey, journeying through the Nicene Creed.

# WE ACKNOWLEDGE ONE BAPTISM FOR THE FORGIVENESS OF SINS

What are we saying, here? For matter, what is this saying doing in a place like this (a creed, about God). Why is this an "acknowledge" statement rather than a "believe" statement?

It's easiest to settle the last question first. "Belief in" in the Nicene Creed is applied to only the three members of the Trinity, three persons of the one God. The Church may have sometimes acted as though it thinks it is God, but it is not. We are still speaking at this point of our belief in the Holy Spirit.

The Spirit's location of choice is the Church. The Spirit did not suddenly arrive on the day the Church was born, the Day of Resurrection or the Day of Pentecost (depending whether you follow John or Luke). The Spirit is here, eternal, pre-existing time, hovering or sweeping, as Gen 1.1 puts it, over the dark primeval waters as time burst out of timelessness. The Spirit is present in the stern corrective voices of the Hebrew Prophets. The Spirit "conceived" the Incarnation in the womb of Mary. But the Spirit's location of choice is the gathering of God's people, the lives of God's people as they struggle-walk through life and faith in all its complexity.

Baptism? Baptism does not bring people into relationship with God. The Spirit does that. But baptism (infant or adult) enacts in the minds of believers the manner by which we are brought into relationship with God. Baptism does not "save": Jesus saves. Baptism reminds us of the process of salvation, our dying and rising within the dying and rising of Christ, the "resurrection of the dead."

The unbaptised are not, as once the Church errantly taught, omitted from the saving work of Christ. They and theirs just don't (usually) have the joy of hearing and enacting the resurrection-promise that is in Christ.

Infant or adult? One speaks of promise (and grace), the other speaks of decision (and grace). Though I strongly prefer the first, I acknowledge it can be much abused. The choice, I believe, should be with families, caregivers and faith-sponsors.

# Diocesan Property Consultation 2020-21

Our property consultation is now open wide with an opportunity for people and groups to have their say via an electronic survey before the end of February 2021.

#### <u>Survey Link (see below for more information)</u> Why are we doing this?

The Diocesan Council has been becoming increasingly caught up in property matters but without having an agreed pathway for how to handle many situations apart from what is set out in Statute 3.

In the Synod held in 2019, the following motion was carried: **That this Synod affirms the Diocesan Council intention to undergo a consultation process around the sale or other use of properties, buildings and other assets within the context of future mission within the Diocese.** 

Some workshops have taken place in Archdeaconry groupings. They have been open to Clergy and Lay Synod reps as well as Parish Wardens, with substitute places available to any Vestry members who have an interest or contribution to make around this property discussion. As this year has been challenging to organise physical meetings, we are also offering a survey option to help us complete the consultation.

# This will help develop a strategy on how we use our property assets to advance God's kingdom.

The survey has the following questions:

- What are the particular dynamics you have around properties entrusted to you? (see pages 2-5 of the Diocese of Dunedin Strategic Property Strategy Consultation Paper 2020)
- In your setting, what is the most important consideration when thinking about

**property and how it can aid your ministry in the future?** (think of this in terms of where you think your Parish might be at in 10-20 years time)

- What is your take on the Strategic Property Criteria? Anything not quite right? Anything missing? (see pages 7-8 of the Diocese of Dunedin Strategic Property Strategy Consultation Paper 2020)
- If you were to rank in order of importance the suggested Strategic Property Criteria, what would this be? (individual exercise)
- What weight would you give to each criterion? (each person will be given 20 dots to "spend" as they want by placing these next to each criteria displayed in the room or entering the numbers into the survey).

After the workshops and the survey has been completed, the combined feedback will be collated and given back to Diocesan Council for consideration. **We would like to have everything completed by the end of February 2020.** 

We hope at the end of this process to have some information that will assist the Diocesan Council and Faith Communities in their decision making around property, with the potential for motions/bills related to property to be taken to a future Synod.

# Privacy Act 2020: New Guidelines for Churches

The new Privacy Act 2020 took effect on 1 December 2020. The privacy principles remain the same but there are some changes to the way these are enforced.

We will clarify this information in the New Year in terms of the roles of the Diocesan Office (Peter Mann House) and Parishes/other organisations responsibilities, but here is what has been shared from the InterChurch Bureau (ICB) so far... What are the changes?

# The Act brings new obligations on all of us with regard to collection, access to, and use of personal information. Key elements are:

- if an organisation has a privacy breach that has caused serious harm to someone (or is likely to do so) ii must notify the Office of the Privacy Commissioner
- the Privacy Commissioner can now issue compliance notices if an organisation is not meeting its obligations under the Act.

#### What is meant by 'harm'?

Harm can include:

- loss, damage or disadvantage
- loss of a benefit or right
- emotional harm (significant humiliation or loss of dignity)

#### What should your church do?

The key step recommended by the Privacy Commissioner is to designate a privacy officer for your organisation, ministry unit, or parish.

The Privacy Act requires organisations to have at least one person who fulfils the role of privacy officer. Larger organisations may require several officers.

#### What is the role of the privacy officer?

The privacy officer should be a responsible and practical person, familiar with the principles in the Privacy Act, who will work to make sure the organisation complies with the Act. The officer's role will include:

- being contacted about and responding to privacy breaches
- raising awareness about privacy among staff, volunteers, and congregations

#### How will the privacy officer respond to a breach?

There are **four steps** in responding to a breach:

1. Contain: find out what has happened and take steps to prevent further harm

**2. Assess:** make an assessment of the seriousness of the breach (for help go to <u>www.privacy.org.nz/notify-us</u> )

3. Notify: if the privacy breach is serious, notify the Privacy Commissioner

**4. Prevent:** when the breach has been resolved, take steps to prevent further breaches.

#### What other help is available?

The Office of the Privacy Commissioner has developed a range of resources to assist organisations to understand and meet their responsibilities.
