The Master of Ministry programme really worked well for me. Being able to pick up the papers I wanted while still practising ministry meant I got to choose the best that was on offer and work it out immediately in my context. Working at my own pace meant I could wait for the papers that really

interested me, and some proved to be real watershed moments in understanding my ministry (Theology and the Arts with Trevor Hart, I'm looking at you!) ## General Information for all Programmes Study Options and Distance Learning

Because these qualifications are offered by distance learning they are suited for those who wish to study from home while in full-time or part-time employment or vocation. Papers may be taught as one-week Intensives with ongoing reflection and assessment throughout the semester. Or they may be taught by video conference, generally with a teaching day near the beginning of the semester.

#### Fees and Enrolment

### More Information on the 400-Level Theology Papers Offered In 2021

Semester 1 with Intensive in Dunedin, Feb 15–19, 2021

MINS 407 Preaching and Communication in a Contemporary Context An exploration of communication issues that affect congregations and ministry organisations today, including interpreting the Bible and preaching in an increasingly secular world.

BIBS 413 God, Suffering and Justice

A detailed study of texts from the Hebrew Bible and related literature that wrestles with the problem of how God can be regarded as just in the face

CHTH 403 The Puritans: Working out the English Reformation The nature, aspirations and theology of sixteenth and seventeenthcentury English Puritans in their historical context, including those Puritans who moved to New England to build 'a city on a hill'.

CHTH 415 Reconciliation, Christian Ethics and Public Theology The challenges posed by social reconciliation in different countries in recent times, and their relevance to Christian Ethics and Public Theology.

MINS 410 Pastoral Care in Dying, Grief and Loss

The role of chaplains, ministers and other caregivers in situation of death, dying and loss, and the ways they can facilitate a healthy grieving process.

BIBS 423 Special Topic: The New Testament Epistles

This paper provides students with the opportunity to study Pauline theology in detail and in depth.

CHTH 405 The Roots of Public Theology Biblical and patristic roots of public theology; the contribution to public theology by thinkers and activists from the 16th-20th century.

CHTH 423 Theology and Human Well-being An investigation of Christian understandings of what it is to be human and their implications for human well-being in contemporary society.

MINS 411 Chaplaincy in Diverse Contexts

The role of the chaplain in diverse contexts, with particular emphasis on the forms of traumatic stress that chaplains deal with in each setting.

MINS 413 Missional God, Missional People

Scripture's story of the missional God and the ways that themes such as call, blessing and liberation have been experienced, re-imagined and lived

#### **Full Year Papers**

BIBS 411 Hebrew Old Testament Exegesis

This paper builds on the study of Hebrew done in BIBS 313 (or the equivalent), advancing students' abilities to interpret biblical texts critically in the original languages by focusing on the exegesis of specific texts

BIBS 421 Greek New Testament Exegesis

This paper is designed to enable students to further develop their translation and exegesis skills in relation to the Greek New Testament.



# Qualifications in Faith-Based Leadership and Management

Postgraduate Diploma in Faith-Based Leadership and Management (PGDipFBLM) and Master of Faith-Based Leadership and Management (MFBLM)

These qualifications have been designed for professionals involved in the leadership and management of faith-based organisations who seek advanced professional education to enhance their work.

The aim of these programmes is to enhance leadership and management in faith-based organisations through study in both Theology and Business Administration.

All papers are available anywhere via Distance Learning.

#### The structure of the qualifications

The Postgraduate Diploma in Faith-Based Leadership and Management consists of 120 points of taught papers. This is made up of three 20-point 400-level taught papers in Theology and four 15-point 400-level taught papers in the area of Business Administration. In each case there is a range of options to choose from.

The Master of Faith-Based Leadership and Management involves the seven taught papers taken for the Postgraduate Diploma in Faith-Based Leadership and Management and a Research Dissertation (MINS590) worth 60 points. The Research Dissertation is 16,000-20,000 words in length and is an investigation of some area of the contemporary practice of leadership and management in a faith-based context.

**NOTE:** The Programme offers workshops on Research Methods for those who have not done a formal course in Research Methods. Participation in these workshops is required for those enrolling in MINS 590

#### Admission

The admission requirement for the Masters and the Postgraduate Diploma is a degree or equivalent three-year qualification in any subject area with satisfactory grades. In cases where the student's prior qualifications do not include theological study, they may be required to undertake one or more 300-level papers in Theology in order to satisfy the prerequisites for specific 400-level papers in BIBS and/or CHTH.

## **Business Administration Papers**

Four papers can be chosen from this list.

All papers are 15 points. There is a maximum class size for these papers each time they are offered, and enrolment in a particular paper is subject to the availability of a place.

## **Qualifications In Chaplaincy**

Postgraduate Certificate in Chaplaincy (PGCertChap) Postgraduate Diploma in Chaplaincy (PGDipChap) Master of Chaplaincy (MChap)

These programmes are professional qualifications designed for

- people who currently work as Chaplains in a variety of settings who seek advanced professional education to enhance their work or
- · people who want to train to be Chaplains.

With the help of Chaplaincy organisations in New Zealand, we have designed programmes that will meet the needs of chaplains in diverse settings.

All papers are available anywhere via Distance Learning.

#### The structure of the qualifications

Qualifications comprise a blend of papers: three core Chaplaincy papers (List A) and a choice of more wide-ranging papers that relate to the general interests of Chaplains (List B).

The Postgraduate Certificate in Chaplaincy involves three taught papers. All three of these can be taken from List A; or two of the three can be from List A with a third paper from List B

The Postgraduate Diploma in Chaplaincy involves six taught papers. These are made up of the three papers from List A, and three additional papers from List B.

The Master of Chaplaincy involves the six taught papers taken for the Postgraduate Diploma in Chaplaincy and a Research Dissertation (MINS 590) worth 60 points (the equivalent of half a year of full-time study). The Research Dissertation is 16,000 to 20,000 words in length and is an investigation of a topic emerging from the contemporary practice of Chaplaincy.

NOTE: The Programme offers workshops on Research Methods for those who have not done a formal course in Research Methods. Participation in these workshops is required. for those enrolling in MINS 590.

#### Admission

Admission requirements for the Postgraduate Certificate, Diploma and Masters programme are a degree or equivalent three-year qualification (not necessarily in Theology) with satisfactory grades. In cases where a person's prior qualifications do not include theological study, the student may be required to undertake one or more 300-level papers in Theology in order to satisfy the prerequisites for specific 400-level papers in Biblical Studies (BIBS) and/or Christian Thought and History (CHTH). Direct Admission to the Master of Chaplaincy requires an average of B+ in the 300-level papers of the undergraduate degree programme.

#### From the Certificate, to the Diploma, to the Master In Chaplaincy

Students who have completed the three-paper Postgraduate Certificate in Chaplaincy may go on to complete the Postgraduate Diploma in Chaplaincy by taking three additional papers. Students who have completed the Postgraduate Diploma in Chaplaincy may complete the Master of Chaplaincy by undertaking workshops on Research Methods and the 16,000-20,000-word Research Project.

### Postgraduate Diploma in Ministry (PGDipMIn) Master of Ministry (MMin)

# Would you like to enhance your work in Ministry?

These programmes are specifically designed for Ministers, Priests, Pastors and others involved in a range of ministries. Linking theory to practice, the aim is the enhancement of contemporary ministries.

The Master of Ministry is a two-year degree. The Postgraduate Diploma in Ministry comprises the first year of the Master's degree. Full-time and part-time options are available.

#### The Structure of the Qualifications

The Postgraduate Diploma in Ministry involves six taught papers, of which three are papers in Ministry Studies (MINS) and three are in Biblical Studies (BIBS), Christian Thought and History (CHTH) and Pastoral Theology (PAST).

The Master of Ministry involves the six taught papers for the Postgraduate Diploma in Ministry and a Research Dissertation of 25,000 – 30,000 words on an issue in contemporary ministry.

The Research Dissertation for the MMin (25,000-30,000 words) is based on original research of an aspect of the practice of ministry. A research proposal, defining the topic and outlining the method, must be approved prior to enrolling. Contact the Department for details of the time periods over which this research may be undertaken.

All papers are available anywhere via Distance Learning.

**NOTE:** The Programme offers workshops on Research Methods for those who have not done a formal course in Research Methods. Participation in these workshops is required for those enrolling in MINS 5.

A minimum of three years' ministry experience is required for the MMin; this is not required in the case of the PGDipMin. A theology degree or equivalent three-year programme of study in theology, with satisfactory grades, is normally required for entry to both the MMin and PGDipMin.
