## How you can pledge your support

Q: How does the Selwyn District Charitable Trust support fundraising for the Tai Tapu Community Centre?

A: The trust has been established as an organisation to which individuals or companies may donate funds for important community projects in the Selwyn district.

Q: Does all of my donation end up being spent on the project?

A: Yes, 100%. There are no administration charges deducted.

Q: As an individual donor how much can I claim as a tax credit?

A: Provided you are a New Zealand resident for the full tax year, you are entitled to a tax credit equal to one third of the amount of the donation.

Q: If I am/we are donating through a company how much can we claim?

A: For companies, a donation to the trust can be claimed as an expense in the company's annual tax return.
