KŌTUI AKO| VIRTUAL LEARNING NETWORK AOTEAROA INAUGURAL GOVERNANCE GROUP CHAIRPERSON'S REPORT PRESENTED TO THE 2023 AGM

I am delighted to be able to present this report on behalf of the Kōtui Ako| Virtual Learning Network Aotearoa (Kōtui Ako) Inaugural Governance Group (IGG) to Kōtui Ako's first AGM.

This last year has seen a significant milestone achieved for Virtual Learning Network Primary (VLNP) and the Online Learning Community (OLC) with the support of school boards, principals, teachers, ākonga and whanau, and the commitment of my IGG colleagues, VLNP Leadership, and e-Principals Rachel Whalley and Amanda King, and their staff. At a VLNP Special General Meeting held on 20 October 2022 and through electronic vote, VLN Primary members agreed to:

- a change in name to Kōtui Ako| Virtual Learning Network Aotearoa;
- adopt a new Constitution which formalises a decision for VLNP and OLC to combine under the VLNP School Trust with the name to be Kōtui Ako| Virtual Learning Network Aotearoa;
- dissolve the VLNP Governance Group, and
- appoint the current Inaugural Governance Group.

Kōtui Ako continues as a registered Charitable Trust with the change of name included on the Charities Register as of 20 October 2022.

OLC was also a Charitable Trust and has delivered online learning to secondary schools since 2003. The agreement of OLC principals and member schools and the leadership of e-Principal, Amanda King, has played a significant role in enabling the merger between VLNP and OLC.

Today, Kōtui Ako delivers online learning to Years 0-13 ākonga through Kōtui Ako Primary and Kōtui Ako Secondary, respectively led by the two e-Principals. Our capacity to deliver the current quality of services to learners in collaboration with schools and teachers is due in no small part to the financial support of the Ministry of Education. This has included support for growing capability in Mātauranga Māori, delivering enhanced learning for gifted learners, Years 9-10 Mathematics intensives, and continuing the Networks of Expertise (NEX) Kōtuitui online teachers' network. Our partnership with Ko Taku Reo| Deaf Education also enabled delivery of New Zealand Sign Language classes in 2022 and continuation of Korean language classes has been supported by the Korean Education Centre.

Future activities will be guided by our recently approved Kōtui Ako 2023 Strategic Plan. We have committed to the following Strategic Objectives:

- To ensure equitable educational outcomes
- To create high quality learning pathways
- To build teaching and learning capacity for online learning
- To honour Te Tiriti o Waitangi to support Māori learners
- To enable a collaborative community of schools throughout Aotearoa
- To advocate for sustainable online learning.

Looking ahead, there are opportunities for Kōtui Ako to better target the needs of Māori learners and learners of isolated and low decile schools; deliver online learning in curriculum areas relevant to both primary and secondary students; expand the impact of the NEX Kōtuitui online teachers' network, particularly for new online teaching staff; work more closely with students to identify their needs; strengthen communication with, and between, participating and member schools; maximise economies of scale arising from the merger, and develop sustainable funding models to deliver equitable learner outcomes to kura, and primary, area, and secondary schools.

In delivering the outcomes set out here, as well as thanking participating schools, principals and teachers, I do want to extend my sincere thanks to my colleagues on the IGG: Rick Whalley (former Chairperson of the Virtual Learning Network Primary Governance Group), Sue Winters (OLC Executive), Rachael Tuwhangai (Independent member) for their ongoing commitment, dedication, and support. I also wish to extend very special thanks to Rachel Whalley (e-Principal, Primary), Amanda King (e-Principal, Secondary) and Sara Field (Deputy e-Principal, Secondary) for their tireless efforts and high-quality guidance and advice to IGG.

The IGG has been delighted to be a part of achieving all that has been undertaken during the last two years and is proud of the outcomes represented in this Annual Report. We are also excited about the opportunities ahead to deliver more equitable online education to primary and secondary learners and wish the incoming Kōtui Ako Governance Group every success in fulfilling these in conjunction with schools, learners and their whanau, and communities.

Report to the Kōtui Ako Virtual Learning Network Aotearoa Annual General Meeting 2023 For the 2022 school year





Kia ora koutou katoa

2022 was a year of significant growth and change for the Virtual Learning Network (VLN) Primary. We had record numbers of ākonga participating while at the same time we went through the process of merging to become Kōtui Ako | Virtual Learning Network Aotearoa.

A huge thanks to Lucie, Jen, Jan and Helen for their mahi that enabled us to cater for a 50% increase in participation from 89 schools and kura, 37 of them new to VLN (More details on participation statistics can be seen in the Snapshot of Learning 2022, attached). It has been challenging to keep the wheels turning and work with so many new teachers and learners. We are privileged to have a team with such depth of professional knowledge and experience that provides a strong foundation for our work.

Our capability in Mātauranga Māori has grown with the appointment of Tewaiehu Savage into our leadership team in July. Tewaiehu has initially focussed on strengthening her understanding and expertise in online teaching and learning and the VLN kaupapa through her work with our kaiako Māori and schools. Her contribution to our leadership group ensures a Te Ao Māori perspective in our mahi. Growing capability in Mātauranga Māori has been a strategic need for us for many years.

In Semester two we undertook a trial funding initiative for U1 - U3 Schools. Kath Johnson, Principal of Halfmoon Bay School, Rakiura/Stewart Island was seconded to evaluate the initiative. Kath's evaluation noted the need for funding support for small rural schools to participate in the VLN.

"In conclusion, we ask that the MoE policy team review curriculum and school funding models to enable greater access for small rural schools to the VLN Primary, thus creating greater equity for our U1-3 schools."

Our participation in Kōtuitui Networks of Expertise continues to make a significant difference in our teachers' professional growth and capability. Kōtuitui provides time and opportunity for teachers to connect and collaborate, and share and strengthen practice. It has enabled teachers to collaborate on curriculum development, and create resources, including several case studies that illustrate how VLN and online learning is working in our schools. It has strengthened connections between primary and

secondary teachers, with both participating together in most PLD activities. Our end of year hui was a highlight with our first 'hybrid hui'. Several teachers attended face to face at the National Library in Auckland while others attended online over a two day period.

Well done to all our tamariki for a successful year of learning in 2022. Special recognition goes to those 92 students who received Special Award certificates for excellence in learning and to those who received prizes in our draw. Congratulations to: Melody Robinson, Tapora School (French); Luke Pyle, Whataroa School (Digital Technology and Te reo Māori); Zeke Walker, Waihi Beach School (Biology); Rochelle Corrigan, Ohura Valley School (Te reo Māori); Savanah Guralaua, Whataroa School (NZSL and Mentoring); William Collins-Lowe, Turakina (Japanese); Nathan Eveleigh, Wairakei Taupo (Web Design). A special mention to Connell Mackay from Tapora School who received the Korean Education Centre award and to Te Rerenga School for outstanding participation and support for online learners.

Our eteacher group grew by eight with James Townshend joining us through partnership with Ko Taku Reo to teach NZSL. Katherine Stewart was engaged to teach across a range of Digital Tech and Design classes. We welcomed Carol Reid and Tatyana Glassie to join our te reo Māori team. Kathleen Saso (Maths & Spanish), Stacey Walden (Astronomy, DT), Carrie VanderZwaag (Gifted Learners) and Rosemary Lee (Chinese) joined our teaching team. We fondly farewelled Koka Jules, our longest standing eteacher, as she stepped into retirement. Thank you to all our amazing eteachers for sharing your knowledge and experience across our schools network.

As always I would like to thank the Ministry of Education for the support and funding they have given the VLN Primary over many years. This year we received funding for Gifted Learners, U1-U3 participation, Kōtuitui PLD, strengthening Mātauranga Māori and Tutoring for Covid lost learning. Without their partnership we would not be able to provide these opportunities for our learners.

As this is my last year reporting as VLN Primary ePrincipal I want to acknowledge a decade and more of VLN online learning in NZ Primary Schools. Grateful thanks to Rick Whalley who pioneered virtual collaborations in 2004 between Pitt Island School and NZ schools and, seeing the possibilities, persuaded the Ministry of Education over several years to support VLN in primary schools. Thanks for the dedicated mahi of our Governance Group established in 2014 and all who served in this role. They ensured a strong vision and solid foundation for our operations.

The VLN Primary has had many highlights and accolades. We showcased online classes in the launch of RBI (Rural Broadband) in 2011, and again for the launch of N4L (Network for Learning) in 2013. We have presented many submissions to the government on 21st Century Learning, changes to the Education Act, Communities of Online Learning (CoOLs) and its subsequent repeal, the Tomorrow's Schools review, and Strengthening second language learning. In recent years we have supported schools during Covid and helped grow teacher capacity through Kōtuitui. We have collaborated with Over the Back Fence (Geoff Woods, Rosmini College) and the Rural & Remote Schools Project, both long running successful collaborative projects. We have led and supported many research projects focussed on improving online teaching and learning. Our Asian Languages contract not only led to the strengthening of our language programmes but opportunities to partner with Confucius Institute and KEC. Our te reo Māori programmes were recognised in Ngā Tohu Reo Māori awards, our Rural Project was recognised by DEANZ and the VLN Primary itself by Internet NZ in Diversity & Digital Skills award. This publication provides more detail in farewelling VLN Primary.

I'm very proud of our achievements and of all the people who have helped make this happen and in doing so make such a positive difference for schools and learners around Aotearoa NZ.






Year Levels






Registrations by Curricula





Kōtui Ako VLN - Secondary Report to the Kōtui Ako VLN Annual General Meeting, 18 May 2023







Our Journey from the OLC to Kōtui Ako Virtual Learning Network Aotearoa

The OLC (Online Learning Community) was, until recently, a Charitable Trust comprising 4 virtual learning networks (VLN) based in the North Island; Farnet, HarbourNet, Volcanics and WelCom. These VLN networks had been in existence for almost 20 years. The leadership across these networks had established a collaborative and symbiotic relationship with one another, and thus the OLC was formed to give a name and identity to this relationship.

While the groups worked together operationally as 'one' organisation, there remained significant variations in the funding models across the networks. A commitment was made between the leadership of the networks, at that time, that alignment in funding models was necessary for the organisation to grow. We felt that would position us as a more cohesive and sustainable organisation. However, we needed to put this development on hold, as we entered into a contract with the Ministry of Education.

In 2021, a Ministry of Education initiative, designed to establish a single National organisation of the Virtual Learning Networks: OLC, VLN Primary and NetNZ, was entered into by all parties. This was an exciting opportunity to align all VLN practices at a national level, with ministry endorsement and the potential for an ongoing MoE partnership. However, 6 months into this work, one party (NetNZ) withdrew from the contract for their own self-interest. Their withdrawal meant an opportunity of a lifetime was lost; the MoE contract was on hold. At this point the relationships between the OLC/VLN Primary and NetNZ had broken down, and trust was lost.

Despite this setback, the OLC and VLN Primary leadership vowed to continue. The result of this has been 18 months in the making; an amalgamation of our two organisations. Now known as Kōtui Ako Virtual Learning Network Aotearoa; the OLC and VLN Primary are no more!

As of 20 October 2022, the Kōtui Ako Inaugural Governance Group officially took the reins of our new organisation. This group of esteemed professionals have dedicated themselves to supporting our leadership teams through our merger, ensuring a fair and transparent process was maintained.

With the amalgamation, a new leadership structure was designed to enable cross-sector strategic planning and rationalise operations. As part of this new leadership structure Rachel Whalley, as ePrincipal Primary, and myself, as ePrincipal Secondary were endorsed by the Governance Group to lead Kōtui Ako VLN and

our respective teams. Kōtui Ako - Secondary is ably supported by an experienced, dedicated team of professionals namely: Sara Field, Deputy ePrincipal, Sue McCarthny, Deputy ePrincipal, and Jan Collier.

Our work together has only just begun. Over the past few months we have, in collaboration with the Governance Group, been developing a new Strategic Plan and vision. Establishing key outcomes for ākonga and aligning our policies and procedures positions Kōtui Ako VLN Aotearoa as a significant, national facing, Yr 0-13 Virtual Learning Network. With our key focus on equity of access for all ākonga, we have a big challenge ahead. With the guidance of our (new) Governance Group, and with the growing support of our Member schools, we will continue to work to that end, and in doing so enable better educational outcomes for students.

Entity's Purpose or Mission

On 20th October 2022, a Special General Meeting of the Virtual Learning Network Primary School was held. The following resolutions were made:

- To change the name of Virtual Learning Network Primary School to Kōtui Ako | Virtual Learning Network Aotearoa
- To adopt a revised Constitution
- To dissolve the Virtual Learning Network Primary School Governance Group
- To appointment an Inaugural Governance Group for Kōtui Ako.

The purpose of these changes was to enable a merger between the VLN Primary School and Online Learning Community (OLC), to establish a national Years 0-13 organisation. A single governance and operational structure provides greater opportunities and efficiencies in funding, staffing and professional support and enables a consistent national approach to flexible online learning in our schools.

For the purposes of this report, the name VLN Primary School is used in the descriptors for Entity Information and the Statement of Service.

Nāku te rourou, nāu te rourou, ka ora te tamaiti.

The Virtual Learning Network Primary School is a collaborative community working online throughout New Zealand to provide improved educational opportunities for learners/ākonga.

Vision: Connected Passionate & Purposeful Learners

- ~ Children are empowered to be connected, confident, digitally fluent, global citizens;
- ~ Provide equitable educational opportunities for diverse learners in a variety of locations with a range of specific needs;
- ~ Broaden children's learning opportunities by participating in flexible and dynamic virtual learning classes that extend beyond the traditional classroom setting;
- ~ Be the leading national learning community for quality online teaching and learning programmes for the New Zealand primary education sector.

The VLN Primary School will achieve this by providing schools with:

- ~ support and leadership for virtual learning;
- ~ effective coordination of virtual learning programmes;
- ~ professional learning to enable quality online and blended teaching and learning programmes;
- ~ personnel to advocate for virtual learning initiatives.



Entity Information

Entity Structure

The VLN Primary School is a charitable trust governed by its participating schools and the wider community. Access to the VLN Primary School programmes and opportunities are open to all, and membership fees are paid by schools who participate. These members have voting rights at the AGM, can stand for the Governance Group and submit remits to the Constitution.

Main Sources of Entity's Cash and Resources

Ministry of Education contracts and participating schools and families are the main source of cash and resources. Ministry of Education contract payments for the VLN Primary School are made directly to a host school, Lake Rerewhakaaitu School, who employ the ePrincipal and Deputy ePrincipal. These payments are independent of the Charitable Trust. Operational funds from this contract are paid to the Trust once salaries are paid. Schools contribute funds to a teaching pool which enables the VLN Primary Trust to pay teachers.

The VLN Primary School is the fund holder for a Ministry of Education Networks of Expertise (NEX) professional learning contract for 2021-2023. NEX supports the development, leadership growth and sustainability of peer-to-peer networks of teachers and kaiako. NEX Kōtuitui is a 'Network of Expertise' for those teaching online in New Zealand schools, who want to teach and collaborate online, and who support online learners (https://hail.to/nex).

The VLN Primary School holds a contract with the Ministry of Education for Gifted Events and Opportunities (2021/2022) to extend access to opportunities for Gifted Learners.

Funding has been received through a VLN Community Ministry of Education contract (NetNZ fundholder) to support the development of a single national VLN entity. This work continues, with Kōtui Ako now the contributor to this work.

Main Methods Used by Entity to Raise Funds

Ministry of Education contract payments, and contributing Schools' payments based on level of participation in programmes. Applications to funding providers and philanthropic organisations who have contributed funding.

Entity's Reliance on Volunteers and Donated Goods or Services

The VLN Primary School is not reliant on volunteer goods or services to operate but has developed partnerships with other organisations to support our operations and extend programmes to schools. For example, partnership with Hail publishing provides us with our communications and website platform; and partnership with the Korean Education Centre funds our Korean teacher. Developing networks of expertise across the community that work with our organisation are an important part of being able to grow our organisation's scope and reach to learners.

Additional Information

The VLN Primary School sits outside but alongside the mainstream schooling setting, working within and across schools. To operate it has had to rely on host schools and a Charitable Trust status. Revenue from the Ministry of Education has been adhoc in its security of ongoing availability. This is not the best-case situation for long term sustainability, development and growth or the professional support and employment of teachers working with the VLN Primary School. The VLN Primary School has worked hard to advocate for support for their operations and for change to education systems that will enable us to operate with an adequate and ongoing level of support and funding.
