Statement of Special Character

Context

• Middleton Grange School is a non-denominational Christian School established for new entrants to Year 13 in 1964 by the Christian Schools' Trust in Christchurch. The School was founded to establish the educational needs of Christian families and present the message of the gospel to children and the community within the context of Biblical truth and practice as recognised by adherents of the evangelical Christian faith. The same Biblical truth and practice encourages a mission perspective. Pupils are expected to support the Special Character of the School.

Who determines and safeguards?

The Special Character of the School is determined by Biblical principles and practice. The Christian Schools' Trust, the Board of Trustees and all staff endeavour to work out those Biblical principles and practices in the School. The Christian Schools' Trust reserves the right to determine from time to time what is necessary to preserve and safeguard the Special Character.

Goals and principal features of Special Character

- The School is a caring community built on Christian beliefs which permeate all aspects of School life. These beliefs recognise God's purposes are revealed in the Scriptures and in the risen Lord Jesus Christ. They are dynamic and determine the purpose and content of the curriculum in a changing community. They were originally expressed, for the School (in a summary form subordinate to the Scriptures), in the annexed Statement of Belief incorporated in the Trust Deed for the Christian Schools' Trust when the School was founded.
- Because these beliefs encompass all aspects of School and permeate the mind and heart of each staff member all staff must demonstrate unqualified commitment to the School's Special Character.
- The objective of the Christian Schools' Trust is to pass on to pupils the truth that all creation is subordinate to the Will of God as expressed in the Scriptures; that all truth finds its meaning and centre in God and that God gives purpose and hope to individuals as well as His creation by virtue of the redemptive work of Jesus Christ. It is the redemptive work of Jesus Christ, communicated by the Holy Spirit operating in the human individual, that gives substance to intellectual, physical, spiritual, ethical, emotional, social and aesthetic development.
- The curriculum, including all the New Zealand Curriculum Statements, is presented within a Christian world view. Such a world view gives perspective and meaning to all learning in the School
- Implicit in the curriculum is the development of character exemplified by the Decalogue and Beatitudes. Such character is the foundation for personal and social peace, just government, responsible citizenship, compassionate neighbourliness, wise parenting and a responsible attitude to creation. Such character also recognises that a life of self-renouncing love is one of liberty.

Enrolment Information 2020

Enrolments

- 1. Enrolments will be accepted mainly at Year 1, Year 4, Year 7 and Year 9 and Years 11-13. Some places may be available at other year levels.
- 2. Enrolments at each of Year 1 to Year 13 will be determined by the spaces available at each year level.
- 3. Class configurations will approximate to:

Year 1-6: two classes at each level Years 7-8: four classes at each level Years 9-10: five classes at each level Years 11-13: depends on subjects/courses

The school will endeavour to establish class sizes approximating to Ministry of Education staff/pupil ratio quidelines.

4. The Board operates a Ministry of Education approved Enrolment Scheme.

Enrolment Procedures

The enrolment procedures for Middleton Grange School shall be as follows:

- 1. Applications must be made on the 'Middleton Grange School Enrolment Application 2020' form. One separate application is to be completed for each child. To ensure fairness, it is important that each application includes all requested information.
- 2. The address for enrolment is: The Enrolment Officer, Middleton Grange School, 30 Acacia Avenue, Christchurch 8041
- 3. All applicants are assessed against the criteria outlined in The Enrolment Scheme.

International Pupils

- 1. Middleton Grange has a full fee paying international pupil enrolment policy. Enrolment of full fee paying pupils are in addition to-the school's approved maximum roll.
- 2. International pupils should request a prospectus from the International College. The Application Form and the Application Form for International Pupil Homestay and Guardianship should be submitted directly to the International College.
- 3. International pupils who change to Permanent Resident status may apply for a domestic place in the academic year following the status change. Applications are subject to the same conditions as all domestic applications.

Enrolment Deadlines

Applications must be received at Middleton Grange School Office by 4.00 pm on the following dates:

Years 7 – 13Closing date: Friday, 14 June 2019 **Years 1 – 6**Closing date: Friday, 23 August 2019

NB: All Year 1 pupils commence on or after their fifth birthday.

The school will inform parents of the starting date.

Attendance Dues 2020

This fee is approved by the Ministry of Education and is payable to the Christian Schools' Trust (CST) as the Proprietors of the school, for the upgrading of existing buildings and the provision of new buildings and facilities together with other property related costs as required by the Ministry of Education under the Deed of Integration. Please note:

- Each pupil will be charged an Attendance Dues fee of \$1,590 pa (GST incl)
- On acceptance a deposit of \$397.50 is payable to the CST which will be applied to the first term's fees
- Attendance Dues will be invoiced by the CST at the commencement of each Term
- An application will only be confirmed on receipt of the original and completed Direct Debit form. A request for another form of payment must be made in writing to the Proprietor.
- Payment can be made by direct debit at the start of each term, monthly or fortnightly
- A discount of \$50 per pupil is available when the full year Attendance Dues are paid at the commencement of Term 1

Special Character Voluntary Donation

One child: \$540 Two children: \$972 Three children: \$1,080 Four+ children: \$1,188

These are fixed by the Board of Trustees, and used to fund items that are not provided for in the Operations Grant provided by the Ministry of Education. These items include extra classes, providing more resourcing into subject areas, school libraries, covering minibus running costs, maintaining smaller classes and delivering a much broader Curriculum than funded for. Most importantly the donation is also used to help maintain the school's Christian character and has tax deductible status.

The Special Character Voluntary Donation will be invoiced by Middleton Grange School and can be paid:

- In full at the commencement of Term 1
- In four instalments, one at the commencement of each term
- In monthly or fortnightly instalments by automatic payment (forms available from the School Office)

School Activities - Course Costs

Some courses incur charges to recover costs where families have chosen to take up a voluntary project or activity within the course. Details of charges are available in the course information booklets. School Activities – Course Costs will be invoiced by Middleton Grange School.

Board of Trustees Scholarships Years 7 - 13

The Board offers two scholarships to assist in cases of financial difficulty. These scholarships are available to pupils across Year levels 7-13. Scholarships are valued at \$785 pa for two years. Pupils wishing to be considered for a scholarship should apply in writing. Please contact the school office for information. Applications for scholarships must be received at the school office by Friday, 14 June 2019.

Enrolment Scheme 2020

Middleton Grange School is a State Integrated School under Part 33 of the Education Act (EA). Section 442 of the EA requires that a Proprietor define a Preference applicant.

A PREFERENCE APPLICANT is a family, which in the opinion of The Christian Schools' Trust, have established a particular connection with the school through membership of, or affiliation with, a church having a Biblical basis of faith consonant with the School's Statement of Special Character as described in s22(a) of the Integration Deed of Agreement.

The school's roll will be managed within the maximum roll prescribed in the school's integration agreement.

PRIORITY AT ENROLMENT

Applications for enrolment of children of preference applicants will be processed in the following order of priority.

FIRST PRIORITY will be given to the children of preference applicants for whom the school is reasonably convenient. [Note 1] If including the children of all first priority applicants would exceed the School's maximum roll then criteria for selection for these children will be based, in sequence, on the second priority through to the seventh priority.

SECOND PRIORITY will be given to preference applicants who are parents of current pupils in the following categories:

- a. Living in the inner zone [Note 2]
- b. Living in the area of reasonable convenience but not attending a Network School [Note 1]

THIRD PRIORITY will be given to preference applicants who are: current permanent Board employees (half time or greater), Board of Trustee members, Board of Proprietor members

FOURTH PRIORITY will be given to preference applicants from another Network school [Note 3] for either of the following reasons:

- a. Their child is graduating from their current school's graduating year level.
- b. A change in residential address which moves them into the inner zone of this school [Note 2]

FIFTH PRIORITY will be given to preference applicants from the school's **INNER ZONE** who are any of the following:

- a. Applying to enrol a child already attending a school which is either:
 - A member of the New Zealand Association for Christian Schools
 - A similar school overseas [and at the time of enrolment will be a domestic pupil]; or
- b. Applying to enrol a child receiving home schooling
- c. Parents of former pupils
- d. Parents who are past pupils

SIXTH PRIORITY will be given to all other preference applicants from the school's **INNER ZONE**.

SEVENTH PRIORITY will be given to preference applicants from **OUTSIDE THE INNER ZONE** but for whom the school is reasonably convenient as defined in Note 1. Priority in enrolment will be given in the following order:

- a. Parents who are past pupils
- b. All other preference applicants

EIGHTH PRIORITY Non-preference applicants. Children of non-preference applicants will be enrolled only if:

- a. Enrolment places remain after children of all preference applicants have been enrolled; and
- b. Doing so will not cause the school to exceed the number of non-preference pupils allowed in its integration agreement. Priority in enrolment among children of non-preference applicants will be given to applicants who meet one or more of the following criteria:
 - a. Who are parents of current pupils;
 - b. Who are parents of a pupil graduating from a Network school

Where the number of places available at any year level runs out within any of the priority levels two to eight above a ballot will be conducted. Children of unsuccessful applicants at each year level will have their names recorded on a waiting list, within their relevant priority category, ranked in the order in which they were drawn in the ballot. The waiting list at each year level will remain current until the board next notifies the public that it is inviting applications for a new enrolment intake.

PRE ENROLMENT

Each year applications will be sought by a date which will be published in a daily or community newspaper circulating in the area served by the School. No enrolments will be confirmed more than one year prior to the proposed date of entry.

NOTES

- 1. AREA OF REASONABLE CONVENIENCE. (Outer Zone) The area bounded by the Rakaia River in the south, the Canterbury/Westland boundary along the Southern Alps in the west, Hurunui River to the North, and the Pacific Ocean to the East.
- 2. INNER ZONE
 - YEAR 1 -10 The area bounded by: the Rakaia river west of the Main South Road, Main South Road, Blenheim Road, Curletts Road, Lincoln Road, Moorhouse Ave, Deans Ave, Harper Ave, Carlton Mill Road, Rossall St, Strowan Road, Wairakei Road, Grahams Road, Memorial Ave, Russley Road, McLeans Island Road, Haul Road, Waimakariri River, and the Canterbury/ Westland provincial boundary.
 - YEAR 11–13 The area bounded by the Rakaia River in the south, the Canterbury/Westland boundary along the Southern Alps in the west, the Waimakariri River to the North, and the Pacific Ocean to the East.
- 3. NETWORK SCHOOL. A school belonging to the Christchurch Christian Education Network (CEN). CEN schools at the time of writing are: Aidanfield Christian School, Emmanuel Christian School, Hillview Christian School, Middleton Grange School, Rangiora New Life, Rolleston Christian School.
