MINUTES OF THE 102nd ANNUAL GENERAL MEETING HELD IN THE CHRISTCHURCH NORTH METHODIST CHURCH CENTRE SATURDAY 19TH OCTOBER 2019 AT 9.30AM

OPENING AND WELCOME

The President BJ Clark welcomed all to the 102nd Annual General Meeting of the Canterbury Justices of the Peace Association Inc.

Attendance was 77 Canterbury Association Members plus Lindsay Dow JP, Royal Federation Southern Regional Representative.

The President welcomed Lindsay Dow from the Royal Federation and also acknowledged the presence of Canterbury Association Patron Hon Lester Chisholm and Past Presidents and Life Members – Mrs Mary Holmes QSM, (LM & PP) Mr Neill Price QSM, QFSM (PP), Mr S S John Wong (PP), Mr Stephen Phillips (PP), Mr Ian Hay CSt.J (PP) and Mr Garth Dale (LM).

The President asked the Registrar to read the Notice of Meeting.

APOLOGIES

Twenty-eight apologies had been received prior to the start of the meetings and recorded by the Registrar. Apologies were also received from Rachael O'Grady Royal - Federation President, Jason Macgregor Hon Reviewer, CJPA Past President and Life Member Stan Hackwell and Past President Bob Macgregor.

OBITUARIES

The Registrar referred members to the list of 14 members who had died during the past financial year. Their names were printed on page 12 and all present stood as a mark of respect to them.

NEW MEMBERS, RESIGNATIONS AND TRANSFERS.

We welcomed 34 new JPs who had been sworn in during the 12 months 01/09/2018 to 31/08/2019 and invited those present to stand and introduce themselves, along with the 6 JPs who had transferred in from other Associations and also 1 JP had re-joined the Canterbury Association.

12 Resignations and Retirements had been received during the year and 5 members had transferred out to other Associations – they were all acknowledged and thanked for their years of service.

PRESIDENTS REPORT

The President BJ. Clark's Report had been circulated and in speaking to his report he commented that as he neared the completion of his two year term of office it had been an honour, privilege and pleasure to have held this office.

There had been many highlights and the top two would have been the CJPA Centenary and the opportunity to host the Royal Federation Conference and AGM in March 2018.

There had also been the opportunity to visit other regions at RF Conferences and Regional conferences and to share experiences and get to know fellow Justices around the country.

Two other areas of the Association require particular mention:-

Service Desks

These have been an amazing success and that is due to the coordination from Gwen Mitchell and the dedication of all who make themselves available to serve on them. The work is often continuous from start to finish with up to four JPs working together on the busiest of desks.

Education Team

The Education Team under the leadership of Yvonne Palmer have tackled head on the need to provide opportunities for Justices to become accredited and the number of Education and Training sessions have been increased and locations around the Association expanded. This has increased our percentage of Accredited JPs from approx. 35% to more than 50%. The team will keep working hard to improve that percentage.

It is imperative that we continue to encourage Justices to become/remain accredited and to attend Education/Training sessions. It is a responsibility in accepting the honour of being a Justice of the Peace that we ensure that we have the ability and knowledge to carry out the work we have sworn to do.

Acknowledgements

"I have been fortunate to have the support of a committed team on the Council and would firstly acknowledge Bob Macgregor who steps down as Immediate Past President. Bob has been a great support and a fountain of knowledge.

To the Council Team who are a group of wonderful people who give many hours of their valuable time to ensure that this organization supports all of our Justices – thank you all.

The Canterbury Association is in good heart and I know that those taking it forward will maintain that.

I also acknowledge those Justices who have passed over and those who have retired during the past year - thank you for your service to the Canterbury Justices of the Peace Association and to the public in general.

Past Presidents Luncheon

I attended the annual Past Presidents luncheon in July – an event held for the past 39 years and for the past nineteen years this has been organized by Past President and Life Member Stan Hackwell. Stan has decided to hand over the mantle and we thank him for his work on behalf of Past Presidents.

Finally the President noted "that this is a wonderful organization, full of people whose dedication and commitment to the public is often little known and underestimated, however I know that public acknowledgement is not why you all carry out your role."

REGISTRARS REPORT

The Registrar spoke to his previously printed report and noted the following points:-

- 2019 had been a challenging year for all in Christchurch and some JPs were at the forefront in helping the families affected by the events of March 15 and it is difficult not to have been affected by the pain and suffering of some of our clients. We all need to both offer and accept support from those around us.
- The Education and Training Team led by Yvonne Palmer have provided many extra opportunities, beyond the normal Education Sessions, for Accreditation Training. This extra effort has resulted in more than 50% of CJPA JPs becoming accredited for the first time or being re-accredited.
- 34 new JPs were sworn in in this Financial Year compared with only 10 in the previous year and interviews and appointments are continuing at a faster rate. The overall time for appointment, from nomination to swearing in has been reduced, and is now usually less than 12 months. Another improvement has been in the gender balance with 57% female to 43% male JPs being appointed
- Communication between Council and members continues to improve with more "hits" on the CJPA website and we owe a big thank-you to Graeme Barber and Lance Kenyon for their hard work in keeping us fully informed.
- The 18 Service Desks operating in libraries throughout the Associations area continue to provide an essential service to the public and in the past 12 months the JPs were involved with 17,774 clients and spent 2,456 hours processing more than 55,000 documents, declarations, affidavits and witnessing signatures. A fantastic effort by teams of dedicated JPs all coordinated by Gwen Mitchell. Our grateful thanks to all of you.
- Some of the other activities not always recognized by the public are the Justices who assist as Police Volunteers, Nominated Persons JPs, Bail Bond JPs and of course the Judicial Justices who serve in the Christchurch District Court. All give freely of their time to make sure the Justice system continues to serve the public as best as possible.
- To President BJ. Clark, Vice President Graeme Barber, Treasurer Garth Dale and the CJPA Councillors I thank you for your support of me in my role as Registrar. To the members of the Association thank you for your willingness to get involved, to attend Education and Training Sessions, to work on Service Desks and serve the public willingly and expertly. JPs have been volunteering in New Zealand for 205 years and for many people we are often the first and only contact they will have with the NZ Justice system.

Finally – we were supported financially again during the year by the Rata Foundation, Air Rescue Services Trust and by Age Concern with the use of their premises – we sincerely thank them all.

ADDRESS BY LINDSAY DOW JP - RF SOUTHERN REGIONAL REPRESENTATIVE

The President BJ Clark welcomed Lindsay Dow to Christchurch and invited him to address the meeting. He brought greetings from the National President Rachael O'Grady who apologized for being unable to be present. Also there were apologies from RF Vice-President Terry Byrne and RF Registrar Tony Pugh.

Lindsay spoke about the significant relationship between the Royal Federation and the Associate Minister of Justice Aupito William Sio, the Secretary of Justice and the Criminal Advisory Group.

Ongoing competency of Justices is still a current issue and discussions on this are continuing with the Ministry of Justice. The accreditation programme is helping to improve the overall number of accredited JPs and Royal Federation are considering the possibility of making accreditation mandatory. No decisions on this are expected anytime soon.

The Best Practice Manual is currently under review along with JP Service Desk guidelines and a new revised Complaints Procedure will be implemented on the 1st November this year.

Lindsay Dow closed his address by extending a warm invitation to JPs to attend the Royal Federation Conference in Hawera in March 2020.

Presidents Report Annual General Meeting October 31, 2020

REGISTRARS REPORT 2019/2020

The first part of 2020 has defined the last Financial Year of both our Association and, indeed, the whole of New Zealand. Who would have contemplated that the graphic, horrifying and tragic events in Christchurch of March 2019 would be almost pushed aside by a worldwide pandemic and an addition to our vocabulary of Corona Virus Covid-19.

In early January we were coming to grips with the serious illness of our Vice-President Yvonne Palmer while she was in Australia and then the announcement of a mystery illness in China. "So far away so it's not likely to affect us here in New Zealand" – these were certainly my initial thoughts about it. How wrong I was. By mid-March we were in Level-2 then almost immediately a Level 4 total lockdown. How life can change in an instant. We joined the "team of five million" and the 1pm daily briefings became compulsory viewing for most of us. Very quickly most of us were also forced to adapt to new ways of doing things. Firstly we were told that JPs do not provide an "essential service" so we all had an enforced rest from dealing with the public and then we had to learn new ways (for most of us again) of communicating with our friends, families, work, schools and organisations.

As an Association we have been fortunate to be led by people who understand both communication and technology. I had to learn very quickly the meaning and operation of things like WhatsApp, Facetime, Skype and Zoom. Emails I understood – everything else was a challenge but if we accept "challenges are opportunities" then most of us rose to the occasion and grasped the new (to us anyway) technology and life carried on.

Your Council worked firstly on Zoom for discussions and keeping in touch and then into formal meetings and making the decisions needed to keep the Association running. All of our usual functions were suspended, including Education and Training sessions and our 18 Service Desks were closed. During the restricted levels the Council formulated a Covid-19 policy which was clear and precise. At level 1 everything operated as normal, at levels 2 & 3 and all meetings and service desks are suspended and at level 4 we are all locked down again.

The Royal Federation provided updates from the Ministry of Justice which were circulated to members and we did our best to make sure that all of you were kept up to date with the MOJ requirements and the reasons for them. Thank you all for keeping to the rules and helping to meet the goal of eliminating Covid-19 from the community. By midnight 7th October all NZ should be back to level 1 and life will return to whatever passes for "normal" these days.

There was a slowdown in new appointments caused by Covid-19 with 23 new JPs being sworn in (compared with 34 last year) – however there are 10 more waiting to be sworn in when Covid-19 levels allow. The overall appointment time – from nomination to swearing-in has also been affected both by the virus and the 2020 general election. This year the balance of the gender gap improved again with more females appointed than males (15 to 8)

Although we gained 31 new members (see membership statistics) we also lost more members than last year with 12 deaths (14) and 34 retirements/resignations (12). Overall our membership has decreased by 16 to 563 as at the 31st August 2020.

Communication has taken on a whole new perspective as we work through these difficult times and as well as our quarterly newsletters we have been sending regular up-dates to members regarding the Covid-19 levels and the changes to schedules for Education and training. Your Council has been working hard to keep everything on track and, just when we had reprogrammed the schedule, we went back to Level 2 and everything was put "on hold" again. Hopefully by the time we get to the end of 2020 we will be back at a more permanent Level 1 and planning will be consistent. The one thing we do know about this pandemic is that nothing is certain and we will just have to stick to the plan we have for dealing with it.

There are many activities carried out by Justices of the Peace and probably the one most in the public eye are the 18 JP Service Desks that operate in libraries throughout the Canterbury Association. The Service Desks were all affected by Covid-19 and all were closed – at the request of the respective local Councils

during levels 3 & 2. The main problem was the requirement to avoid queues and to maintain physical distancing. While the service desks were missed by the public, once they reopened they quickly went back to pre-lockdown levels of activity.

Some of the other activities not always immediately recognised by the public are the Justices who assist as Police Volunteers, Nominated Persons JPs, Bail Bond JPs and of course the Judicial Justices who serve in the Christchurch District Court. All give freely of their time to make sure the justice system continues to serve the public as best as possible.

To President Graeme Barber, Acting Vice President Neville Brown, Treasurer Garth Dale and the CJPA Councillors I thank you sincerely for your support of me in my role as Registrar during the past (and at times very difficult) 12 months and to you – the members – thank you for your patience, your adaptability and your willingness to continue to serve your communities to the best of your abilities.

During the past year we have again been supported by generous donations from Rata Foundation (administration expenses support), Air Rescue and Community Services Trust (Royal Federation 2020 Conference support), Age Concern (Meeting Room and photocopying support) and a \$2,000 grant from The Southern Trust to assist with the upgrade of the CJPA website. We thank each organisation sincerely for their valuable assistance.

We don't know what is ahead for any of us. A general election in New Zealand which will be decided by the time this report is presented and a new government to be installed. Whoever wins it will be new government with new changes and challenges to be faced. On the world scene a critical decision to be made by the voters in the USA and the ongoing effects of this worldwide pandemic – who knows what 2021 will produce but through it all Justices of the Peace will continue to serve the public in NZ - just as they have for the past 206 years.

EDUCATION REPORT - 2019/2020

Education: -

The Education Team started the year under the convenorship of Yvonne Palmer. Sadly, Yvonne was not able to continue in this role due to ill health and subsequently resigned as a Justice of the Peace. I was appointed by Council to assume the role of Convenor. The Education team thanks Yvonne for her leadership and contribution to JP education.

Education team members are: - Rod Paton *(Convenor),* Graeme Barber, Neville Brown, BJ Clark, Gwen Mitchell, Adrienne Sears, and Ken Shields.

Our year commenced with a full programme of education and accreditation sessions across the CJPA District.

Unfortunately, our programme was adversely affected by the impact of Covid 19. This resulted in education sessions being suspended from 21 March until 30 June, and again from 12 August until 21 September. Our programme was reviewed to reschedule as many of our sessions as possible.

By the end of this year, education sessions will have been delivered at: -

- Rangiora
- Cheviot
- Darfield
- Amberley

The education team has worked hard to deliver sessions to assist Justices in their roles, through revision of core activities and instruction on statutory and other changes. Periodically we invite keynote speakers to our sessions who present on topics relevant to our roles. We are grateful to those speakers.

The education team welcomes suggestions from members as to topics they would like to be addressed at education sessions.

The team thanks the many Justices who regularly attend our education sessions. It is always a great pleasure to interact with fellow Justices and to share knowledge and experiences. However, it is very disappointing that some members attend few or no education sessions!

 Clause 2 of the Code of Conduct of the Royal Federation of New Zealand Justices' Associations (Page 9 of the Justices of the Peace manual) states: -

"Justices of the Peace shall: maintain a working knowledge of the duties, responsibilities and obligations of a Justice of the Peace by regularly participating in ongoing education provided by their Associations or Royal Federation."

It is pleasing to note that some of our newly appointed Justices are taking the opportunity to sit in with experienced Justices to observe Library Service Desks in action. This exposes new Justices to a wide range of JP activities and is an excellent way to learn and to build confidence. It also encourages new Justices to join service desk rosters. Our thanks go to fellow team member Gwen Mitchell for her work as Service Desks' Convenor.

Accreditation:

For this year, Council set an accreditation target of 70% of members. An ambitious plan was developed to deliver accreditation sessions in various locations. Unfortunately, this plan was severely hampered by Covid 19 and some sessions had to be cancelled. To enable accreditation opportunities to continue, a "remote" accreditation option was introduced. By this method, Justices are sent the accreditation questions by email. When Justices have researched their answers, they are discussed with a member of the training team to ensure correctness and are then given instructions to complete accreditation on-line. This has worked extremely well with around 40 Justices completing their accreditation by this method this year. Another 32 Justices have completed accreditation by attending the 4 face to face sessions that were able to be held. This "remote" method will remain one of the tools in the education toolbox along with face to face sessions. Currently, approximately 62% of members are accredited. - Our thanks go to team member Neville Brown for his work in convening accreditation sessions.

Induction:

Induction sessions for provisionally appointed Justices have been held during the year. These sessions are conducted by Rod Paton, Ken Shields, and Gwen Mitchell.

Issuing Officers:

An education session for Issuing Officers was delayed due to Covid 19 but will be programmed as soon as it can be arranged.

The role of Justice of the Peace is an honourable one which carries demanding responsibilities and obligations. The thanks of our team go to members for showing their commitment to the role by

Communications Report

Annual General Meeting October 31, 2020

The Communications team are responsible for keeping members informed via the Canterbury Justice of the Peace Association (CJPA) website, quarterly newsletters and emailed updates as deemed necessary.

With COVID-19 impacting us all in ways un-foreseen and often with very little lead time, the need for more frequent and just in time communications created many more opportunities.

Your agile, proactive and responsive Council, and communications team Graeme Barber & Lance Kenyon) compiled significantly more articles and mailouts than last year.

Website

The website is the front page of the CJPA for any search by the public for information about and for services from its members. Where our website appears on a google search is based on its history of 'hits' over time. The aim is to ensure it remains near the top of any search, for Justices of the Peace in Canterbury, so that the chance of public accessing a site that does not value currency of information held is reduced.

Many thanks to members who have helped to retain our position near the top of any search by frequently opening www.ipcanterbury.org.nz.

A visit to our web site provides members and the public easy access to content about the Association, contact details, celebrations, education/training events, how to find a Justice of the Peace, the quarterly newsletter and a calendar of events.

With the desire by Council to separate what members can access from what is publicly accessible our 'Hail' based site is currently being reconstructed. Members will be advised by email when the upgraded site goes live.

Newsletters

Newsletters are compiled quarterly and supported when needed by special updates/blogs and event reminders. These newsletters, and updates, are stored and archived in a 'cloud' based repository. This enables a wider range of articles and photos to be uploaded from the 'cloud' as this method is less reliant on the capability/capacity of any members device. The practice of opening links rather than being emailed attachments has become the norm internationally due to file size limitations when emailing.

Links to publications and articles are emailed using 'hailmail' with the data base used updated frequently from member information provided by Registrar Ken. Emails to article links are being delivered to over 95% of members with the number of members opening them fluctuating significantly.

Members training and contact details

Keeping your contact details up to date is essential if reliable access by the Public to a Justice is to be maintained. The Royal Federation of New Zealand Justices Associations (RFNZJA) new website recently went live and provides easy navigate access to a wide range of resources and information needed by both the public and Justices.

Any access and other questions can be discussed either with the RFNZJA staff or a CJPA Council member. We are here to help.

Keeping an accurate record of attendance at training/education sessions will assist members Accreditation renewal process. Information about this is contained in our Useful Resource article on the website and regularly in newsletters. A 'How to' step by step set of instructions for members is available on our website and in recent newsletters.

2019 - 2020 Judicial Justice of the Peace Report

In the last 12 months there were 455 hours spent by Judicial Justices carrying out their duties in the District Court. The COVID restrictions meant there were no Thursday Courts from Mid March until Mid July and no Bail Courts from Mid March until early May.

We presided over 490 traffic related cases and heard 45 other matters. The Bail Courts saw 676 applications, 138 of which were flagged as family violence. We also presided over 14 Youth Court hearings.

Training has been ongoing, with a focus on domestic violence and traffic issues.

Drew Garden retired from the Court Panel in August after a period of five years. Thank you Drew for your fellowship and sound judgements in your time as a Judicial Justice.

August was a very sad month for us as Russell King passed away. It was Russell's goal to return to the court but his illness proved too high a hurdle for him to overcome. Russell started doing Bail Bonds in 2010 until 2016, then completed Judicial course in 2016 and started working on the Bench in January 2017 until ill health struck in February. Russell had also been an Issuing Officer since 2012. Everyone who knew Russell couldn't help but like him – his cheerful manner endeared him all who knew him. He was a valuable member of our team and is missed.

We have one person currently in training and look forward to him joining us later in the year carry out our duties.

Bob Macgregor completes our annual peer review. His positive and constructive feedback is always welcome. Thank you, Bob, for the work you do with this.

Thank you, Nick Atkins, Greg Clapp, Gray Crawford, Billie Watmuff and Andrew Webster for your outstanding commitment to the Judicial Justice panel. It is such a pleasure to work with these exceptional people who are totally focused on giving the very best service they are able to.

Planning Committee Report to Annual General Meeting 2020

Neville Brown - Sep 4 2020

The Planning Committee has been made responsible for Policy Development and forward planning activities for the Association.

A key policy position Council has taken is that Service Desks and Justices should not work in a Covid Level above 1, in the interests of all party's Health & Safety. The impact on our customers can not be underestimated.

During the year to date, the following activities have been undertaken:

Annual Workplan

A workplan for the 2020 year has been developed and approved by Council for implementation. Key elements of this plan were:

Accreditation penetration within membership to achieve 70% of members. This was decided on the basis that at end of January, we had achieved 60%. An ambitious education plan was developed to deliver accreditation education in a number of areas, rather than the traditional centralised model. Unfortunately this work has been severely hampered by Covid but we will ramp up again as soon as we can all be in Level 1.

Membership Survey.

A short membership survey was developed and released with our September newsletter to all members. The results of this work will be released later in 2020, the results will inform our work going forward.

Policy Publication

Council has approved a number of policies for CJPA and these are now published on our website for the information of members. This includes a specific COVID policy that details under what conditions our

members can work, in accordance with Ministry of Health guidelines. Several of these will need a formal review by the incoming Council for 2021.

Service Desk report 2019/2020 by Gwen Mitchell

Sincere thanks to all our coordinators and Justices working on our 18 service desks. From 01 September 2019 to 31 August 2020 our 18 desks have provided **2,456 hours of service**, **seen 17,761** clients, certified **44,612** copies, handled **7,808** statutory declarations, **709** affidavits and **2,311** other documents.

Amazing, impressive statistics which show how appreciated and utilised our service desks are. Our desks would not run smoothly without our desk coordinators and Justicesthank you.

We also thank our libraries who host us, enabling us to provide a walk in, walk out service in a warm, friendly, safe environment. Our partnership with the libraries has never been stronger.

It has been a challenging year with Covid-19 and our desks were suspended for quite a few weeks. Remarkably we still saw 2,289 more clients than in the previous year.

The CJPA Council policy drafted in August 2020 stating "service desks would only operate during Covid level one" made it easy to understand when our desks would be operating.

Three of our service desk coordinators have stepped down over the last twelve months......Stan Hackwell from Rangiora, Lenore Barrow from Kaiapoi and Barry Straight from Halswell. Sincere thanks Stan, Lenore and Barry for all your work over the years coordinating these desks.

We were delighted to have Neil Falconer take over as coordinator of Rangiora, welcomed Neill Price as coordinator of Kaiapoi and Ray Pearson as coordinator of Halswell and appreciated April Lander becoming coordinator of Parklands. Sincere thanks for taking these roles on.

This year we provided another certifying stamp for certifying electronic documents . That makes a total of four stamps in our JP satchels at each desk.

Four Bibles have also been donated. One went to each of the three Waimakariri desks and the other one is in the Lincoln satchel. We hope to get more and will slowly distribute them.

This year has seen a number of new Justices sitting in on our service desks (needs to be arranged beforehand) and this provides a wonderful opportunity to buddy up with an experienced Justice and

witness first hand the range of work we handle. Often these new Justices will join one of our desks which helps us tremendously to maintain our service desk Justice numbers.

We ask that all Justices working on our desks be accredited which shows we are all keeping up with our education so we can provide the best, possible service.

When I took over as Convenor in 2016 there were 10 service desks operating only on Tuesdays. We made the decision that any future desks opened would be on alternative days. Since then another 8 desks have been added and we have changed Fendalton to a Saturday. Rolleston also now operates two days a week which means we have 10 desks out of the 18 operating in Canterbury on alternative days to a Tuesday.
